2. Hair sample should be sealed in a plastic Ziploc bag with name of exhibitor, name of specie, and all individual animal identification written on outside of Ziploc bag in permanent marker.
3. Immediate family members (brothers & sisters living at the same address) may enter animals as a family. Please list all exhibitor information on the above form.
4. DNA samples should be submitted in a 8 1/2 x 11 envelope to C.C.A.I.S PO Box 311 Marshall, MI 49068 or they can be dropped off at the office during business hours.
5. This form and DNA samples must be postmarked, by May 15 for sheep, swine, dairy starter and goats. NO EXCEPTIONS
6. Envelopes **MUST BE CLEARLY MARKED SWINE, SHEEP, DAIRY STARTER OR GOAT.**
7. **Each specie must be submitted in separate envelopes.**
